



Introducing Broker (IB) Agreement



This Agreement governs the relationship between Elefin and any individual or entity (the “Partner” or “IB”) approved to introduce clients to Elefin.

Parties & Acceptance

This Agreement is between Elefin Ltd, Saint Lucia Company no. 2026-00297 (“Elefin”) and the Partner. By submitting the partnership application or accepting these terms electronically, the Partner agrees to be bound by this Agreement together with the Partner Program Terms, the Commission Policy and the Marketing Guidelines, as amended from time to time.

Appointment

Elefin appoints the Partner on a non-exclusive, non-transferable basis to introduce prospective clients. The Partner acts as an independent contractor — not an agent or employee of Elefin — and has no authority to bind Elefin, open or operate client accounts, handle client funds, or give investment, tax or legal advice.

Partner Obligations

1. Promote Elefin lawfully and professionally, in line with the Marketing Guidelines and the laws of every jurisdiction targeted.
2. Make no misleading, false or guaranteed-return statements, and never misrepresent Elefin, its products, pricing or status.
3. Provide true, complete information and complete the partner verification required before commissions are paid.
4. Not target or onboard clients from restricted or sanctioned jurisdictions, nor (at launch) UAE residents / Emirates ID holders.

Partner and client identity verification (KYC/CDD) is governed by Elefin’s approved AML & ATF Policy.

Commissions

The Partner earns commissions calculated and paid under the Commission Policy and Partner Program Terms, based solely on Elefin’s records. Elefin may withhold, recalculate or reclaim commissions arising from fraudulent, abusive or self-referred activity, or where a client’s deposits are reversed, charged back or refunded.

Client Ownership, Data & Confidentiality

All introduced clients and their data belong to Elefin. The Partner acquires no rights to client data and must not contact, solicit or misuse it. The Partner shall keep the terms of this Agreement and all non-public information confidential during and after the term.

Brand & Intellectual Property

The Partner may use Elefin’s name, logos and materials only with prior written approval and strictly per the Marketing Guidelines. The Partner shall not register or use any domain, app, handle or business name containing “Elefin” or confusingly similar terms, nor bid on Elefin brand terms in paid search.

Term, Termination & Liability

Either party may terminate on five (5) business days' written notice; Elefin may suspend or terminate immediately for breach, suspected fraud or where required by law. On termination the Partner must cease all promotion and use of Elefin materials; Elefin pays validly accrued, undisputed commission save where withheld under this Agreement or the Commission Policy.

Governing Law

This Agreement is governed by the laws of Saint Lucia (to be updated on Mauritius licensing); the courts of Saint Lucia have jurisdiction. The English version prevails. Elefin may amend this Agreement and related policies on prior notice.
